Moot Court now is one of the biggest and efficient sources from where Students get the education and experience of real Court trial.

The applicant of the case is a Husband who tries to resolve his fight with his wife who left husbands house and four children and went to her maternal house. Here the husband tries to bring her back to continue Conjugal relations between them. But the respondent i.e Wife responds that her husband has immoral relationship with other woman. Before approaching to Court the husband with the support of elders attempted to resolve but failed.

The Final Verdict of the Court was in favour of the husband. Due to no proven evidences of the wife's claims, court ordered to live peaceful married life.

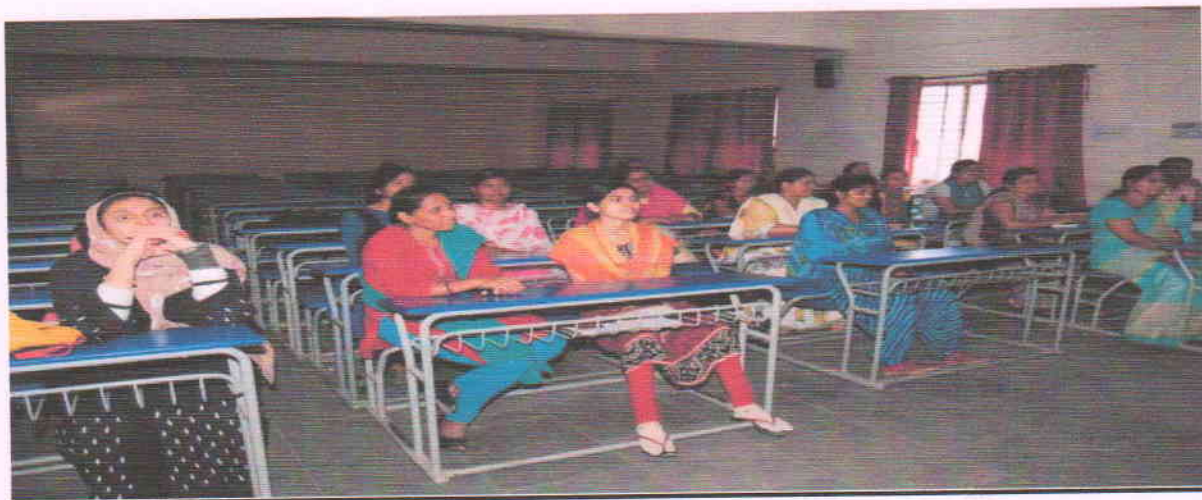
