It is one of the modern methods of giving practical knowledge to the students by putting them in a hypothetical situation similar to that of a real court and then two teams each on one side argue upon Fictional/Trialed cases. Moot Court now is one of the biggest and efficient sources from where Students get the education and experience of real Court trial.

Objectives:

- 2. Moot Court is a great place to hone public speaking skills.
- 3. It helps to gain immense practical knowledge about various fields of law.

Report:
